

Children and young people

Kids in Communication - Team Kicsters!

Funded £5,000 from Positive Futures Fund

Kids in Communication is based in Wolverhampton and aims to support young people of all ages, cultures and backgrounds with a range of positive activities. Since being established in 1996 they have worked with over 10,000 young people providing volunteering opportunities, running activities and events to increase skill levels and give them a platform from which to access support, training and employment opportunities.

Kicsters is their exciting new sessional based project which encourages those at risk of involvement in anti-social behaviour to become part of the Kicsters team - not join a gang.

By using the latest technology such as a digital graffiti wall, radio studio, DJ decks and gaming wall they get the young people involved and learning new skills.

They work primarily with young people aged 14-20 to hopefully inspire them to make better choices for themselves and their future

Wheels and Toes - Lets dance!

Funded £1,000 from Coventry Building Society Fund

Wheels & Toes based in Harborne, Birmingham is a dance class with a difference. With a volunteer as a partner it allows people with physical disabilities to dance and enjoy the music.

Set up by Barbara & John Marshall the group provides fun dance activities for wheelchair users enabling them to get involved in something different, increase confidence and make friends with other, like minded disabled people. Everyone who attends, has the opportunity to design and perform their own routine, including different types of dance such as waltz, tango and bhangra.

They even have an accordion player amongst their ranks who plays whilst they dance the St Bernards Waltz!

The Hummingbird Centre (Midlands)

- Understanding and the opportunity to talk with others.

Awarded £1,976 from The James Kenning Fund

In 2012 the founder of The Hummingbird Centre (Midlands) was diagnosed with breast cancer. During her 10 months of treatment and 6 months recovery she felt there was a lack of non-medical support in the area. She started to develop ideas of an organisation that could provide support to people diagnosed with cancer as well as their family and friends.

The centre was opened in Rugby in November 2014. It supports anyone affected by cancer in the Rugby, Coventry and Warwickshire area. It specifically aims to reduce feelings of isolation felt by people affected by cancer as well as support their physical and emotional wellbeing.

Initially open for just one day per week it increased its opening hours in 2015 to two days. So far it has engaged with over 90 people affected by cancer; 60% who have been diagnosed with cancer, 20% caring for someone with cancer. The centre offers counselling, complementary therapies, a craft morning, meditation sessions and talks on various topics.

"Good opportunity to meet people who are also going through or have gone through similar journey to yourself."

"It gives me companionship, as sense of hope and purpose & a wealth of experience from fellow survivors and their partners." DID YOU KNOW?

Last year there were over 22,300 people living with or beyond cancer across Coventry and Warwickshire.

Leamington Studio Artists - Community Painting

Awarded £1,900 from the Coventry Building Society Fund

To celebrate the varied history of the town of Royal Leamington Spa a group of local artists came up with the idea of creating a community painting – a huge 4m x 2m panel made up of 336 individual canvasses each painted by a person from the local community.

Based on a huge 'paint by numbers' style painting each person was given a canvas with the faint outline to follow and a printed sheet to show what colours to use where.

The painting was completed over the weekend of the Art in the Park event at Jephson Gardens and was a huge success From toddlers being helped by parents to grandparents all ages joined in and painted a panel; the youngest was 3 and the oldest 85. Each panel was laid down

to dry but the final image was kept as surprise for the unveiling at the Library a few weeks later.

The final result was stunning based on 12 iconic symbols of Leamington including circus elephants, Terry Frost imagery, tennis balls and gaming icons.

IAG (Information. Advice. Guidance) Job Club

Funded by £1,000 from Red Nose Day Community Cash

A few years ago two local men in Sutton Coldfield decided to set up a Job Club to help local people with information, advice and guidance. They felt there was a lack of local provision. Both were qualified level 4 advisers and one had worked as a teacher in Maths and English.

IAG Club offer a number of services including CV evaluation and creation to confidence building, looking at interview techniques and providing mock interview situations.



Aston Athletics Basketball Club

"It's a good session it's sick!"

Funded £4,952 from Comic Relief Community Cash

Youth Education Through Sport (YETS) is the latest initiative at Aston Athletics Basketball Club. It aims to reduce crime, antisocial behaviour and increase employability for those who take part. Young people (aged 16 -19) who are at risk of becoming NEET (Not in Education, Employment or Training) will be guided towards further education to help them achieve their future potential. The project will provide educational and physical activity as well as volunteering roles within local community programmes.

Participants are given the opportunity to gain NVQ's in sports coaching, refereeing & officiating, opening up their options for the future.


Based in North Solihull the project covers areas of deprivation and it utilises sports as an engagement tool to encourage those who are hard to reach in these communities. They offer access to a sustained, reliable service that helps the participants feel part of something that is actively making a difference to them and their local environment.

Ilmington Community Shop

More than just a shop.

Awarded £1,900 from The Heart of England Fund

With the closure of the Village Shop in 2012, Ilmington was left without a store for the first time in living memory. Residents faced a six mile round trip to the nearest shop, and the village became a place of isolation for many, particularly the elderly and those living alone. The social hub of village life had gone and was sorely missed.

After two and a half years of determined and tireless hard work, the Ilmington Shop Committee and scores of village volunteers celebrated the opening of the Ilmington Community Shop in May 2015.



Achieving Results in Communities (ARC)

Creating greener events!

Awarded £1,000 from Warwickshire Recycling Fund

ARC have been facilitating recycling at The Leamington Peace Festival, the Warwick Folk Festival and the Leamington Food and Drink Festival since 2011.

Every year they work hard to try and limit the amount of recyclable waste going to landfill working with the organisers who want their events to be as environmentally friendly as possible.

With over 35,000 festival goers they wanted to increase signage for the recycling facilities and increase the amount of volunteers working on event days. This year they are doing recycling for the first time for Warwickshire Pride, and hope to get more events to think about more sustainable waste management in coming years.





Supporting older people



Bell Green Silver Surfers

Thursday is the best day of the week as its computer class!

Awarded £772 from Coventry Building Society Fund

Every Thursday a room in the Bell Green Community Centre becomes a hub of computer activity as the Bell Green Silver Surfers get online!

The group was formed back in 2008 to offer computer training to older people from the local community. Participants get support on sending emails and using the internet to shop, book holidays and keep in touch with family and friends at home and abroad. It gets them out of the house meeting new people and exercises their minds.

With new tablets to allow more of the group to Skype distant friends and family members the group are really getting to grips with new technology. They have also purchased some headsets for those in the group who are hard of hearing.



Harry Payne Fund - Case Study

Harry Payne was born in 1884 in Northampton. He left school at the age of 11 and went to work in the boot and shoe industry. He turned out to be a talented cobbler and became determined to open his own shoe repairing business so in 1908 he moved to Birmingham with £20 in savings. He found a small house with a shop in Balsall Heath which he rented for 10 shillings and 5d per week.

The business grew and by 1914 he had three shops but then came the outbreak of World War One. Harry declared that on Christian grounds he would not assist the war effort so he served his time in prison as a conscientious objector and was not released until January 1919.


By 1924, he had 14 shops and a central head office and warehouse. The company continued to grow at a steady pace and by the early 1960's there were 150 shops across Birmingham and wider region of the West Midlands. The company was floated on the Stock Exchange in 1963.

With the success of his business Harry became uncomfortable with the trappings of wealth and started donating to local causes. He quickly realised that it would be more effective to create a charity so in June 1939 the Harry Payne Trust was established. It aimed to help the underprivileged, older people and children.

In 1970 the capital of the Trust was £127K; this had grown to £1.5 million by the end of 2014.

By 2014 many of the trustees were retired and decided to look at ways to ensure the trust for the future. They chose to hand over the administration of the trust, along with the Trust's capital of just over £1.5 million to the Heart of England Community Foundation. The Foundation matched the trust with £750,000 from the Government's Community First Endowment Match Challenge. The yearly income from the investment is awarded to support projects and since April 2015 over £93,000 has been granted to 124 projects. Some of the original trustees from the trust still sit on the decision making panel and are supported by the team at the Foundation.

Harry Payne died in 1981 at the age of 97 leaving behind a legacy for communities across Birmingham and wider region of the West Midlands.
