FOREWORD

I took over the Chair of the Foundation in October 2021, determined to drive forward with the direction set by my friend and predecessor Phil Ewing, above all to make a real difference to the lives of people in our region.

The Foundation has emerged from the COVID-19 pandemic a stronger and more resilient organisation – i proved over those two years that in a time of crisis it could step up to the mark. We must now adapt to the new pattern of working and the new social context that we face, as the cost-of-living crisis and the legacy of COVID-19 put communities and voluntary groups under more pressure than ever. The need for the work the Foundation does has never been greater, and we are determined to do everything we can to meet that need.

2021/22 was a year when many charities were struggling to pick up and maintain activity as the pandemic unwound. Despite this, the Foundation managed to distribute almost an impressive £3M of grants into our communities. I was also particularly pleased to note that

93p in every £1 that the Foundation receives is passed on to the good causes that we support.



We will also look to work with national funding programmes and local authorities to maximise the resources we can deliver into our communities.

INTRODUCTION



But my worries were short lived as we have continued to work with our existing donors and secured new donors who believe in the work of the Foundation. You can find out more as you turn the pages in our Yearbook.

We launched our 3-year strategy in 2021-22 with a clear focus on improving our customer journey, externally evaluating our work, and passing Quality Accreditation 5.

We understand the challenges the voluntary sector faces in applying for funds, so we implemented our 'single front door.' This enables organisations to complete one application form rather than multiple applications for the programmes we currently manage. This was an extensive piece of work, but I hope it demonstrates our commitment to deliver accessible funding.

We commissioned Forever Consulting to undertake a place-based analysis of the West Midlands and Warwickshire, and to evaluate the impact of our grant making over the last 3 years (excluding the pandemic year). We wanted to better understand our communities, use the intelligence gathered to shape and prioritise our work and identify gaps in reach and communities of interest. This has given us an evidence base to where our funds are most needed and will enable us to have informed conversations with both new and existing donors.

We did it!! We passed Quality Accreditation 5 with flying colours, as part of the UK Community Foundations (UKCF) network quality accreditation is undertaken every 3 years. It is a lengthy, evidence-based process but provides an excellent opportunity to sound check the way we work, our governance, policies, procedures, board, and future planning. We also scored exemplary against our 3-year financial pipeline, our strategy, and our board composition in terms of age, gender, and diversity.

Looking ahead to 2022-23 our focus will be on reengaging with our communities. We'll be delivering a series of roadshows across the whole region, focusing on areas of deprivation, with the aim of attracting new organisations and particularly welcoming applications from communities of interest.

We are developing a funding and marketing strategy with the hope of attracting new donors who want to invest their money at a local level.

Finally, we know that there are more challenging times ahead with the cost of living and energy crisis, so we'll do our utmost to be there for our voluntary and community sector.

As ever, thank you to everyone who supports us.








APRIL 2021

NEW



This partnership opens up another route for the Charity's funds to reach organisations working with people in need.

Taking advantage of the Foundation's endowment match offer, the Alan Edward Higgs Charity has made their money go further by partnering with the Foundation to set up a £500,000 endowment fund to support vital community activity across Coventry and Warwickshire. This fund will be invested into the Foundation's endowment portfolio, which sees the interest distributed as grant funding every year and the investment will remain as a legacy for the region.

Marilyn Knatchbull-Hugessen, Chair of The Alan Edward Higgs Charity, said:

"The Trustees have long been aware that it is very difficult and time consuming for small grass roots organisations

to make successful applications to grant making bodies. Accessibility to funding is crucial for small organisations. The Heart of England Community Foundation has long experience of ensuring that funds reach such organisations.

"By supporting the match funding challenge, the Trustees can ensure that more funds are available to meet needs at the grassroots. Community based activity needs quick and easy support if it is to be effective in meeting needs in their community. Fundraising should not be their constant worry."

One huge benefit of being a member of the UK Community Foundations network (UKCF) is that we have opportunities to be part of delivering national funding programmes to benefit groups in our region. Made By Sport is a charity which raises awareness of the power of sport and delivers funding for organisations that use sport to support young people across the UK.

The Foundation awarded over £249.000 through the Clubs in Crisis Fund to clubs and community organisations using sport to improve young people's lives.

Raising The Level use football as a tool of engagement to bring young people together from diverse backgrounds.

They were awarded funding to develop their volunteers and purchase new equipment.

Denise Richards, project lead at Raising The Level, said:

"This grant has helped us to continue and develop our club, especially after the impact of Covid. Our young people have returned to sport, helping them to socialise with their peers and improve their physical and mental health.

"Sport is important to everyone as it brings communities together, as a diverse football club with members from Black Caribbean, West and North African, White British, South Asian and mixed parentage descent, sport can create a positive impact on social and community cohesion."



2021



Deaf World, a charity that works in partnership with deaf and hard-of-hearing young people received a grant to deliver the Life Skills Driver Training Programme to twelve young people aged between 17 and 25 living in the West Midlands. The aim was to enable and empower them to acquire driving skills creating pathways to more career options.

Sammey, a support worker at Deaf World, shared:

"I volunteer for Deaf World, as a Deaf person I'm passionate about encouraging the service users to get involved with our projects to reduce isolation, learn new skills and improve their mental wellbeing. It's been great to work on the Driver Training Programme. Aisha, one of our beneficiaries, is just a fantastic person and was very enthusiastic about the project. It was great to see her hard work and perseverance pay off and now she has the independence of being able to drive!"





SUPPORTING PEOPLE IN HARDSHIP

We continued to grow and strengthen our relationship with Orbit as we were awarded the contract to deliver all their individual grants for customers. This is a great opportunity for us to continue to grow our grants portfolio and demonstrate the range of services that we offer our donors. We support Orbit to deliver their grants under four themes: Hardship, Wellbeing, Digital and Employment,

It was great to receive feedback from an Orbit customer about the difference one of these grants has made to them:

"The Orbit Wellbeing grant has provided me with an opportunity to learn a new skill, provide a distraction to my thoughts and I am actually doing

something without thinking too much. I have been provided with the opportunity to be practical and skilled. I can actually produce an end product. something to be proud of. This grant is providing me with a positive space and outlet, thank you, '

"We are delighted to continue our relationship with the Foundation. They offer an exceptional service, which is timely and efficient and have worked with us in partnership to respond quickly to the continued challenges which impact our customers, which is so important for us when supporting our customers in crisis and hardship. 

JULY

2021



David East decided to work with the Foundation to support projects tackling disadvantage through community initiatives. He said:

"I believe HoECF can make the best use of my money due to their knowledge of local community issues. It's often the case a small amount of money can make a huge difference."

The David East Fund supported Our Community Foundation, a charity based in Birmingham, with a £1.745 grant. The funding enabled the charity to deliver an eight-week programme of educational workshops to raise awareness of the challenges facing young people. The workshops included the detrimental personal and social impact of taking and selling drugs, helping young people to build resilience and to develop life skills.

AUGUST 2021

PAYROLL GIVING

During the pandemic, staff from Deutsche Bank wanted to support local communities and had seen our work on social media. Colleagues were volunteering in their local communities but wanted to do more and decided to sign up for payroll giving, donating regularly through their pay to the Foundation. Tina's biggest passion is the communities and

organisations we support, and she recognises the huge value community organisations and charities play across our region on a day-to-day basis. Tina was recognised for her inspirational leadership of the Foundation and for championing the voluntary and community sector.

The Foundation's response to the crisis during the pandemic is something that many of these beneficiaries will never forget. Though it was tough, Tina stayed positive, lifting those around her and supporting the region with all the resources she could get, offering not only security but also a voice to those who needed it the most during what was an uncertain time for all.

SEPTEMBER 2021



BUILDING BETTER LIVES

I came here and they gave me a key of my own to my own room. I had never had my own key before.

Black Country Women's Aid opened their specialist refuge which features 12 safe, welcoming flats and a new reception centre for women rescued from modern slavery.

This has been made possible thanks to a grant of £800,000 from the Foundation's Building Better Lives programme. The grant enabled them to purchase and

refurbish the refuge, design and build the reception centre, which doubles as an activity space to hold therapeutic groups and activities to help women rebuild their lives. The expansion also sees the installation of a memorial garden dedicated to those who have lived in the existing accommodation, and those who never got the chance.

CYCLING FOR HoECF



The High Sheriff of Warwickshire, Lady Min Willoughby de Broke, has been a huge supporter of the Foundation through her fundraising efforts. She embarked on a 5-day cycling challenge across Warwickshire to showcase the people, organisations and independent businesses that make it the best it can be to live, work and visit. She also took part in other fundraising events, raising over £31,000 for the High Sheriff of Warwickshire Fund.

Lady Min Willoughby de Broke said:

"The voluntary and community sector in Warwickshire is a shining beacon of hard work and selflessness. There are so many incredible people who put service before themselves by helping others less fortunate.

"The least I could do as High Sheriff was to raise as much money as possible to say thank you to these wonderful individuals and through my efforts give them extra funds to help ensure they could carry on their extraordinary work."

OCTOBER 2021

Over the year the Foundation was independently assessed on its compliance with the agreed Quality Accreditation Standards. The programme is unique to the UK Community Foundations (UKCF) network, providing the only

NOVEMBER 2021

The Foundation was delighted to deliver a £1 million Social Impact Fund for Warwickshire County Council. We awarded 28 grants to community organisations across the county to tackle inequality and social inclusion.

Warwickshire Community and Voluntary Action (WCAVA) received £93.000 to make essential capital improvements to its Nuneaton community centre, the Newtown Centre.

Alison Thompson, Area Manager for CAVA said:

The rooms are lighter, brighter, warm and dry, it really has breathed new life into our much loved community building and massively impacted our community!



DECEMBER 2021



We've been working with Make Good Grow; a social enterprise that matches businesses that want to give back to good causes. We teamed up with them to kick start the festive season by launching the Christmas Count-Up campaign (a give-back advent calendar) which successfully matched 24 local good causes with 24 skilled volunteers to support the organisations in delivering a range of projects.

We asked community organisations across our region to share a project they needed help with - including marketing, accountancy, digital skills, fundraising, event management, community engagement, corporate fundraising and copywriting. Make Good Grow then matched volunteers who wanted to give back to a local good cause in time for Christmas.



JANUARY

2022

We are supporting West Midlands Combined Authority (WMCA) to deliver their Community Green Grants scheme. Grants are being awarded to community groups and regional organisations, especially in deprived communities, that help connect people to nature, improve green spaces or enhance the local environment.

Sustainable Life in Birmingham received £16,000 to clear 1.6 acres of brambles at the Ten Acre site in Stirchley to increase accessibility for the public and to maintain habitats for local plants and wildlife.

Stephanie Bale. Treasurer at Sustainable Life, said:

"Ten Acres is a fantastic and under-used park right in the heart of the city, and with this funding, our team of volunteers will ensure it continues to be developed into the beautiful and biodiverse woodland it is capable of being.

"By increasing access to the site and improving its conservation status, we will ensure its legacy for decades to come."

Graham approached the Foundation after discovering that we could ensure his money reached the communities he cared about. We launched the Graham Griffiths Fund to support those communities most in need across Coventry and Warwickshire.

"As a Midlander, I wanted to help local charities

and good causes where relatively small sums of money can have a large and immediate impact on individuals. HoECF answered all these requirements perfectly. I discovered it would be possible to establish my own foundation under its auspices. This would result in lower set up and running costs, and no administrative burden compared with doing it myself."

A NEW WAY TO APPLY

JANUARY 2022

As part of our journey to become a more accessible funder we have decided to implement a new way to apply for our funding programmes. Following feedback from applicants, we have developed and trialled the single application form. Applicants were involved in the design and testing phase. The purpose is to take the responsibility of deciding what funding best meets project requirements away from applicants and onto us, reducing applicants time and effort in applying.

Hannah Fielder, a Community Engagement Worker at Redeemer Church, shared:

"I was thrilled when the application process was streamlined even further into one form for all the different pots available. What a good idea! It makes a big difference to us being a small charity and spending the majority of staff time delivering projects rather than doing admin. Thanks so much HoECF - we genuinely couldn't deliver what we do without you!"

SOLIHULL CELEBRATING COMMUNITIES

In partnership with Solihull Metropolitan Borough Council, we launched the Celebrating Communities Fund to support community activity to improve disadvantaged communities.

Art at the Heart CIC combats inequality and supports wellbeing through creative and cultural educational activities. They were awarded £5,000 for their project to celebrate the Hindu Holi Festival of Colour in March 2022.

Holi is an ancient Indian festival that celebrates spring, love and new life through vibrant colour. The funding enabled them to deliver art activities for multigenerational members of the community, at any skill level, to create new interpretations of Holi. The workshops included Splat Art, Bubble Art and a giant community colour weave.

Eesha, a volunteer, shared:

"Volunteering at Art at The Heart allowed me to develop my art and be involved in the community; volunteering alongside Mukesh and Kamaljit helped me flourish by giving me indispensable skills such as time management, leadership and problem-solving.

"The whole team were dedicated to creating a memorable experience for our community, and it was amazing that they were bringing the cultural celebration of Holi to the centre of Solihull, and really immersing everyone in this experience. In my opinion, this spirit of community is really reflected in the values of Art at The Heart and is what makes it unique as an organisation."

SUPPORTING OLDER PEOPLE



FEBRUARY 2022



Working with Birmingham City Council, the Neighbourhood Network Scheme (NNS) Fund delivers grants to support older people within the wards of Edgbaston and Northfield.

We are working alongside the three lead facilitator organisations in Edgbaston and Northfield - Age UK Birmingham, Gateway Family Services and Northfield Community Partnership. The fund is supporting local community projects that improve social and physical activity, transport and mobility, benefitting underrepresented groups and delivering arts and cultural activities.

Due to the programme's success, Birmingham City Council has committed to making funds available to deliver the NNS programme across the City including in Northfield & Edgbaston NNS Fund for a further seven years.

Shencare Community Transport was awarded £10,000 to provide a transport service in Northfield. They provide an affordable and accessible door-to-door escorted passenger transport service for community groups, older people, and people with disabilities.

The Foundation, alongside the network of community foundations, welcomed applications to the Arts Council England Let's Create Jubilee Fund. We awarded over £330,000 to support community and voluntary organisations to develop creative and cultural activities as part of Her Maiesty The Queen's Platinum Jubilee celebrations. This allowed communities the opportunity to experience the best of the country's culture whilst also celebrating this once-in-a-

lifetime milestone in our national history. Anuragi Devi Dasi, a project lead at Shree Shree Radha Krishna Cultural Centre, shared:

"We're heartily grateful for the funding to celebrate the Queen's Platinum Jubilee in a diverse manner. The funding will help us to create cohesive relationships within the community by encouraging beneficiaries to take part. This will improve their confidence, skills and awareness."







NEW DONOR

Mayflex UK partnered with the Foundation to launch the Mavflex UK Community Fund to award community activity and grants to groups within a 10-mile radius of their site for young people. in Aston, Birmingham, The fund will support projects

CITY OF CULTURE

On winning the title 'UK City of Culture 2021' in 2017, the Coventry City of Culture Trust partnered with the Foundation to fund local artists and the cultural sector to develop their practice. support organisations to grow and which engaged Black, Asian and build new networks, and enable new ideas in preparation for the city's year of celebrations to begin.

As part of this programme, the Trust were keen to work with underrepresented communities in the arts and cultural sector. This included funding Black artists, projects for early years children, the LGBTQ+ community and accessibility initiatives for groups across Coventry and Warwickshire.

Throughout the year we have awarded 21 grants totalling £82,454 to support these communities.

Upholding our commitment to representation and inclusion for all, the LGBTQ+ Community Grants, which were also supported by the Esmée Fairbairn Foundation, funded individual artists or organisations with creative ideas to make a difference have the same passion as me, to the LGBTO+ community in Coventry and Warwickshire.

Steppers UK CIC delivers services

promoting and advocating for stronger diversity, access, and representation within the outdoors. They received £10,000 through the Black Artists fund for their 'Beyond The City' project ethnic minority communities by exploring and documenting green spaces within Coventry.

Susan began hiking with Steppers in May 2021, she said:

"I wanted to be part of a walking group with others that looked like me."

"After my retirement in 2018 and the eventual lifting of Covid restrictions, my passion for walking in nature increased and I came across Steppers UK. My experience to date has been nothing short of a positive, enjoyable one. I enjoy exploring the countryside on foot and breathing the fresh air. Most of all I find walking the best form of exercise. Steppers has allowed me to connect with others who and it's been a great space for meeting and forming friendships."




